- Have served on a MMA task force/committee for a minimum of one year OR provide equivalent service to the industry as deemed acceptable by the Nominating Committee.
- Term: 1 year as president-elect and then automatic succession to president for 1 year.

### Director (Professional or Wholesale Correspondent) (6)

#### Requirements & Term Information

- Must be a current Professional or WC Member in good standing.
- Must have a valid registration with NMLS, or be lawfully exempt from requirement.
- Have served on a MMA task force/committee for a minimum of one year OR provide equivalent service to the industry as deemed acceptable by the Nominating Committee.
- Term: 2 years. (2024 and 2025)

### Director (Affiliate) (1)

- Must be a current Affiliate Member in good standing.
- Must have a valid registration with NMLS, or be lawfully exempt from requirement.
- Have served on a MMA task force/committee for a minimum of one year OR provide equivalent service to the industry as deemed acceptable by the Nominating Committee.
